Civil Rights Data Collection 2015-16 Data Notes

About the CRDC Data

The Civil Rights Data Collection (CRDC) is a biennial survey required by the U.S. Department of Education's (Department) Office for Civil Rights (OCR) since 1968. Similar to the 2011–12 and 2013–14 CRDC, the 2015–16 CRDC collected data from a universe of all public local educational agencies (LEAs) and schools, including long-term secure juvenile justice facilities, charter schools, alternative schools, and schools serving students with disabilities.

The CRDC collects data on leading civil rights indicators related to access and barriers to educational opportunity at the early childhood through grade 12 levels. The CRDC is also a longstanding and critical aspect of the overall enforcement and monitoring strategy used by OCR to ensure that recipients of the Department's Federal financial assistance do not discriminate on the basis of race, color, national origin, sex, and disability. OCR relies on CRDC data it receives from public school LEAs as it investigates complaints alleging discrimination, determines whether the Federal civil rights laws it enforces have been violated, initiates proactive compliance reviews to focus on particularly acute or nationwide civil rights compliance problems, and provides policy guidance and technical assistance to educational institutions, parents, students, and others. In addition, the CRDC is a valuable resource for other Department offices and Federal agencies, policymakers and researchers, educators and school officials, parents and students, and the public who seek data on student equity and opportunity.

Response Rates

Traditionally the CRDC has achieved very high overall response rates. The response rate for the 2015-16 collection was 99.8%. This included 17,337 LEAs and 96,360 schools. An important consideration for response rates is that the reporting process requires all schools and LEAs to respond to each survey item on the CRDC. Some LEAs, that did not have complete data, reported a zero value. It is not possible to determine all possible situations where this may have occurred. As such, it may be the case that the item response rates may be positively biased. For the large majority of CRDC survey items, the rate of missing data ranged from 0-5% of reported values.

Race/Ethnicity

CRDC student count data are generally reported by race/ethnicity, sex, disability status, and English learner status. CRDC uses the 2007 race and ethnicity guidance published by the Department. The guidance includes seven race and ethnicity categories (American Indian or Alaska Native, Asian, Black or African American, Hispanic or Latino, Native Hawaiian or Other Pacific Islander, White, and two or more races). Privacy Protection

In order to prevent disclosure of individuals, data in the public use file have been rounded or replaced with a special reserve code. Data elements with small cell values have been suppressed and replaced by a special reserve code of -2. For other counts and numerical data elements, values were rounded. Calculated totals are based on rounded data.

Data Anomalies

As part of a comprehensive data quality review process, OCR identified *priority* data issues that were based on data anomalies identified during and following the data submission period. LEAs (and some SEAs) with data quality issues were targeted for outreach and given an opportunity to correct and recertify their data. A total of 4,386 LEAs were contacted to correct anomalies in the data. Of those contacted, 41% (1,784) of LEAs did not participate in the outreach phase; 52% (2,229) of LEAs were able to make edits and re-certify their data; and 7% (303) of LEAs did not submit corrected data but were able to provide explanations for the data anomalies. Less than 1% of LEAs responded stating that they refused to participate in the data quality corrections process.

Other Data Anomalies

Processing Errors

There were instances when the online submission tool did not function as expected. A summary of those issues follow.

Juvenile Justice Module

There are a total of 608 juvenile justice facilities in the data collection. Due to a system error, over 400 of those facilities were not able to completely report data for data elements in the juvenile justice module. A data element that should have been reported (but was not) is identified with a special reserve code of -7 in the data file.

Auto Zeros

A reserve code of -5 is used to indicate that an LEA was unable to report all required data elements for the current collection, but developed an action plan to be able to report those data elements in the future. Every data element related to the action plan should have a code of -5 in the data file. Due to a system issue, LEAs can have a mix of -5s and data values. The most common scenario is where there are -5s and zeros (0) for those data elements related to the action plan.

Skipped Data Elements

A reserve code of -9 is used to indicate that a data element is not applicable (and should be skipped) based on a response to a precursor question. Every skipped data element should have a code of -9 in the data file. Due to a system issue, the skip logic did not always function as expected. Some questions that should have been skipped were not. Those questions were displayed to the LEA in the submission tool and the LEA entered a zero (0) to avoid having a null field. An example of this is with the Single-Sex Interscholastic Athletics data. If an LEA indicated a school did not have students who participated in female-only interscholastic athletics, questions related to female-only sports should have been skipped. While many of these questions were skipped, some were not. To avoid having the empty data field, the LEA would enter a zero (0).

The Sworn Law Enforcement Officers indicator question was inadvertently carried over from the 2013-14 data collection and displayed in the submission tool for 2015-16. This carryover caused a reporting issue with the SCH_FTESECURITY_LEO data element. Although the data element was required for all schools, the data element was skipped for over 69,000 of those schools. A special code of -9 in the data file for the SCH_FTESECURITY_LEO data element indicates the submission tool skipped over the question for the school.

Data for all LEAs in Florida

The Florida State Department of Education, on behalf of its school districts, submitted data for the 2015-16 CRDC. However, more IDEA students were reported as having not passed an Advanced Placement exam than students enrolled in the Advanced Placement Course. In addition, Algebra I passing data for 7th and 8th grade students consist of mostly zeros. This is due to the nature in which the state of Florida records Algebra I on student's transcripts for all of its LEAs and schools.

Data Errors Corrected

A data correction is revised data for a data element (e.g., enrollment numbers for female students). OCR does not allow LEAs to make amendments to the data after the close of the collection. However, OCR recognizes that minor corrections to the data may be necessary. The CRDC accepts data correction requests from LEAs for up to one year from the time the submission period closes. For the 2015-16 collection, the corrections period closed on June 30, 2018. The following LEAs submitted data corrections and those corrections are included in the September 2018 data release. The data corrections are listed by data file.

Limitations of CRDC Data

The submission tool includes a series of embedded edit checks to ensure significant data errors are corrected before the LEA submits its data. Additionally, each LEA is required to certify the accuracy of its submission. Only a LEA superintendent, or the superintendent's designee, may certify the CRDC submission. Ultimately, the quality of the CRDC data depends on accurate collection and reporting by the participating LEAs.

Although OCR has a robust quality process designed to prevent, detect, and remediate data integrity issues, some inconsistencies still remain in the data file. All known data anomalies are noted in this data documentation.
